## PARTICIPATION WAIVER

## PLEASE READ BEFORE ACKNOWLEDGING:

In consideration of being allowed to participate in any way in the City of Prattville Parks and Recreation's programs, including participating in any way with the skating rink (hereafter referred to as "activity"), the undersigned acknowledges, appreciates, and agrees that:



I am 18 years of age or over or the Parent or Guardian of a child wishing to participate in the activity, and I desire to participate or allow my child to participate in the City of Prattville Parks and Recreation Department's activity.

I consent to participation in the activity and acknowledge that I fully understand my participation may involve risk of serious injury, including cuts, bruising, breakage of bones, muscle and tendon strains and sprains, or death, including losses which may result not only from my own actions, inactions or negligence, but also from actions, inactions, or negligence of others, the condition of the facilities, equipment or areas where the event or activity is being conducted, and/or the rules of play of this type of event or activity. I also under that these risks increase with larger groups, and I understand that if I have any risks concerns, I should discuss the risks associated with my or my child's participation with the activity coordinator and event staff, before I sign this document and before the activity begins.

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others or my or my child's negligence and assume full responsibility for my participation.

I certify that I and/or my child am/is in good health and have no physical condition that would prevent participation in this activity. Furthermore, I agree to use my personal medical insurance as primary medical coverage payment if accident or injury occurs, and I consent to emergency medical treatment in the event such care is required.

I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual, significant hazard during my presence or participation, I will remove myself from participation and bring such hazard to the attention of the nearest official immediately.

I, for myself and/or my child, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the City of Prattville, The Parks and Recreation Department, BH Skating Parks, Chill Entertainment, their co-sponsors, representatives and successors, WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

I have carefully read this waiver of liability agreement and understand the terms used in it and their legal significance. I am aware that this is a release of liability, hold harmless agreement and assumption of risk agreement and it is a legally binding contract. This waiver and release is freely and voluntarily given with the understanding that right to legal recourse against the City of Prattville, the Parks and Recreation Department, BH Skating, dba Chill Entertainment, owners, directors, employees and agents of each of them is knowingly given up in return for allowing my participation in the activity. My signature on this document is intended to bind not only myself, but also my successors, heirs, representatives, administrators, and assigns. I sign this agreement of my own freewill.
